

The Nuremberg Trials - The Complete Proceedings, Vol 8: Crimes Against Humanity (The Third Reich From Original Sources)





Synopsis

This is the eighth volume in the complete proceedings of the Nuremberg trial of the German major war criminals before the International Military Tribunal sitting at Nuremberg, Germany. Taken from the original court transcript this volume covers the proceedings from 27th February to 11th March, 1946 and represents an essential primary source for scholars and general readers alike. The transcripts are complete and contain the whole of the proceedings as taken from the original court documents. This volume includes evidence of the extermination of the Jews from all over Europe, experiments on living people, the murder of mental patients, atrocities against children at Auschwitz and the British Government's report on the murder of 50 RAF officers from Stalag Luft III. It contains the testimony of Abram Suzkever, a highly regarded poet, who was an instrumental witness in the trial of Franz Murer, the â⠬˜Butcher from Vilniusââ ¬â,¢ who was responsible for the deaths of his mother and son. A A It also incorporates the submission of evidence by Goeringââ ¬â,,¢s defence, notably General Karl von Bodenschatz, who was the liaison officer between Goering and Hitler until the July 20 Plot in 1944, who was later sentenced two years in prison, and Erhard Milch, a German Field-Marshal of Jewish descent who oversaw the development of the Luftwaffe. Goering suppressed rumours of his ethnicity, and issued him with a German Blood Certificate, stating famously $\tilde{A}\phi\hat{a} \neg \hat{A}$ "Wer Jude ist, bestimme ich $\tilde{A}\phi\hat{a} \neg \hat{A}$ • (I decide who is a Jew). Milch was later found guilty of war crimes and crimes against humanity and sentenced to life imprisonment, though was later released in 1954 and died in Dusseldorf in 1972. Originally published under the authority of H.M. Attorney-General by His MajestyA¢â ¬â,,¢s Stationery Office London in 1946, this new ebook version includes an introduction by Emmy award winning writer and historian Bob Carruthers.
