

The Case Files series have been the mainstay of my study routine for my junior clerkships in medical school. But this one has SOOOO many typos that it makes me question the validity of the content. It is peppered with misspelled words, unfinished sentences, there's one spot where the author actually left a note to himself to look up whether or not a comma was used appropriately. It's like the rough draft went into publication. I plan on continuing to use Case Files, but I'm pretty disappointed with this one.

Great review of Internal Medicine that actually makes you think about what you would do for that patient rather than just bullet points. I like that it doesn't always give you every bit of information you need and makes you narrow/confirm your ddx with further tests.
