

The company also has pled guilty to manslaughter in a separate criminal case, but no one responsible for the tragedy is going to prison. BP Blowout provides new and disturbing details in a definitive narrative that takes the reader inside BP, the White House, Congress and the courthouse. This is an important book for readers interested in the environment, sustainability, public policy, leadership, and risk management.

I was hoping to get a book that detailed the deep water horizon as a history of events. While some of that existed, the book delved between the author dishing out lessons on environmental and business ethics to events surrounding the disaster. Maybe I should have gone with 3 stars, but given my boredom and reading for the sake of finishing put me in the 2 star slot

Had to put it down midway through chapter 2. There were so many errors that were just plain frustrating, I felt that early in the book that I couldn't trust any other facts presented. From simple math to stating that the spill occurred in the wrong year. The tone of the book was a bit snarky for me too. I'm a Gulf scientist and as outraged as anyone else about the spill, but the author's tone makes it feels as if it was a personal assault on him. It also just didn't flow well. Sections were disjointed and awkwardly juxtaposed. I often felt the same things were stated multiple times in different places and that other information was inserted where it didn't fit.

This is a terrific book for anyone who wants to get their hands around the details of the BP Gulf oil disaster, from the company culture, to the specific decisions leading up to the blowout, the trial, the regulatory responses and future prospects. Professor Jacobs really hits full stride beginning with Chapter 6 when he tells the inside stories of the legal battles, the trial, and government attempts to spin public perceptions of its decisions, both before and after the spill. It's a remarkably quick read, but one packed with a wealth of information that provides a full and factual picture of what transpired in the Gulf. Definitely five stars!
