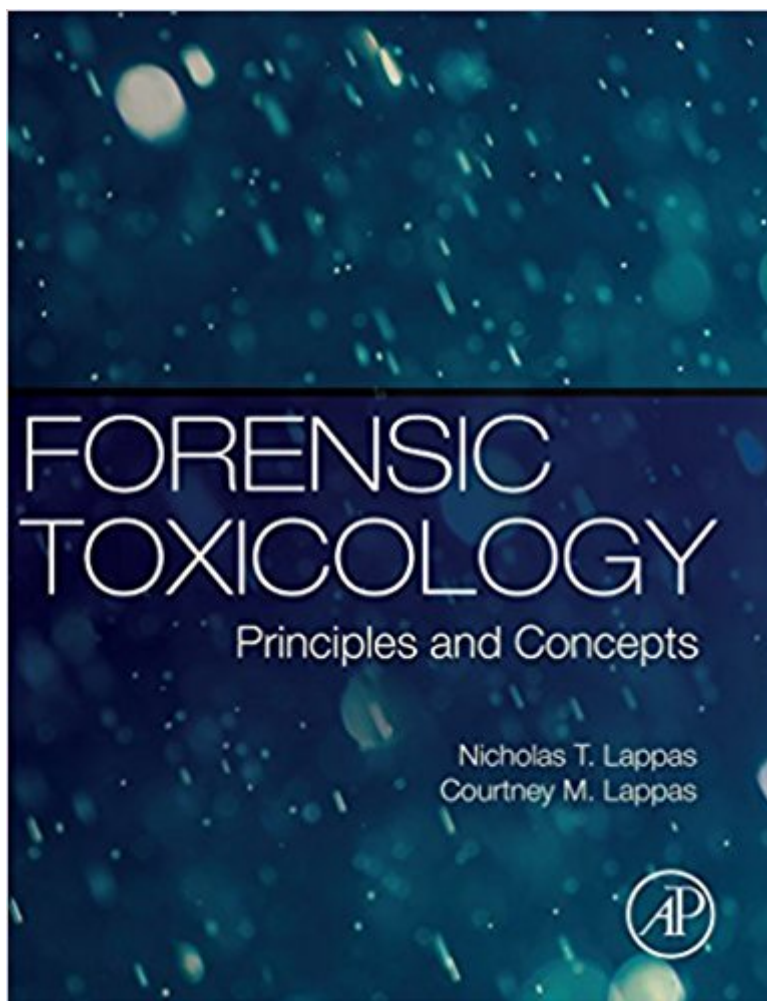

An Immunopharmacologist, Dr. Lappas teaches Molecular Biology, Immunology and General Biology. Previously a Fellow at the National Institutes of Health, Dr. Lappas's research interests are translational in nature and focus on the utilization of novel pharmacological tools in the treatment and/or prevention of immunological pathologies.
