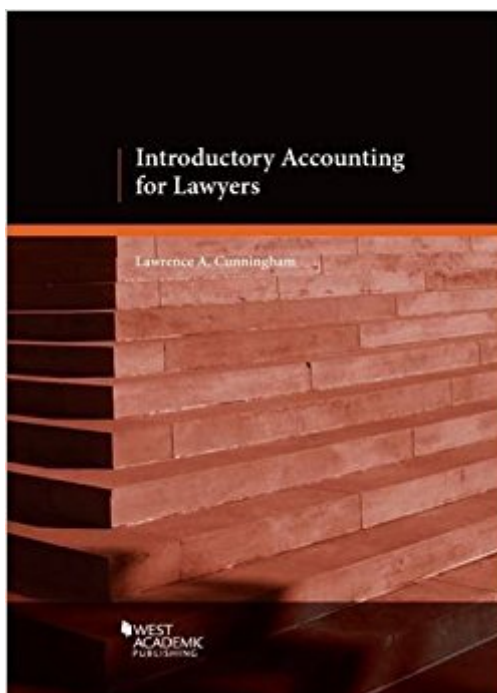

You have to refer back to previous chapters to do the problems and most of it will go over the heads of law students. It was even confusing to me and I've taken an accounting class. I honestly feel sorry for law students who have to use this book.

This textbook is exceptionally awful. The lack of "big picture" contexts throughout the text makes it very difficult for a lawyer without an accounting/econ background to have any idea what the author is talking about. The definitions and explanations use the most convoluted possible way of defining each word and laying out each process. All I found in this book was frustration and confusion.
